## Congratulations on achieving your recent *Eat Safe Brisbane* star rating!

Let your stars shine and proudly display your good food safety rating for everyone to see.

The following information will assist your business to promote its food safety star rating. To get the maximum benefits from the star rating display materials provided by Council, it is recommended that:



The large sticker is placed on a window or glass door near the front entrance of your business.

If your business does not have a front window, you may wish to place the sticker in an A5 perspex display stand instead.



The small sticker can be placed prominently on or near a cash register, counter top or other suitable location.



The star rating certificate can be framed and placed near the front entrance of your business or wherever you currently display your food licence certificate.

**Please do not place any display material in or near food preparation areas.**





## Promote your star rating

Council encourages you to promote your *Eat Safe Brisbane* star rating. Copyright laws mean that you cannot reproduce the *Eat Safe Brisbane* sticker, certificate or Brisbane City Council logo in any advertising, promotion or website. However, you can use the following text on your business website or other promotional material.

**"<Name of business> has achieved a <3, 4, 5> star *Eat Safe Brisbane* food safety rating!"**



If your business received **3 stars**, you may also include:

**"This business demonstrates a high level of compliance with the *Food Act 2006* and overall good food safety management practices."**



If your business received **4 stars**, you may also include:

**"This business demonstrates a high level of compliance with the *Food Act 2006* and overall very good food safety management practices."**



If your business received **5 stars**, you may also include:

**"This business demonstrates full compliance with the *Food Act 2006* and overall excellent food safety management practices."**
